TERMS AND CONDITIONS OF SINGLE-PREFERRED PROGRAM

- Candidate understands that membership in the Club is subject to approval and payment of the required Membership Fee and any applicable taxes.
- Candidate acknowledges that membership is not an investment in the Club, Owner, Operator or any other entity, nor does membership provide an equity or ownership interest in the Club, Owner, Operator or any other entity, or the facilities of the Club (the "Club Facilities"), and that membership is for recreational use of the Club Facilities only.
- Candidate acknowledges that a member only acquires a revocable license to use the Club Facilities in accordance with the Membership Documents. The Club reserves the right, at any time or from time to time, in its sole and absolute discretion, to reserve memberships, to discontinue operation of any or all of the Club Facilities, to sell or otherwise dispose of the Club Facilities in any manner whatsoever and to any person whomsoever, to terminate any or all types of membership, and to make any other changes in the terms and conditions or benefits of membership or use of the Club Facilities.
- Candidate covenants and agrees to indemnify and hold the Club, Owner, Operator and their members, partners, shareholders, directors, officers, employees, representatives, affiliates and agents harmless in accordance with the provisions of the Membership Documents.
- Candidate acknowledges that use of the Club Facilities may be restricted from time to time based on events, construction, renovation, maintenance and other causes. The Club, Owner and Operator shall have the right to offer other types of membership and dues categories from time to time, in their sole and absolute discretion. The Club, Owner, Operator and their affiliates, agents and assignees shall have the right to use the Club Facilities for all of their business purposes and may designate certain other individuals or employees to use the Club Facilities. Such use may be at a reduced rate or complimentary basis. The Club may, in its sole discretion, enter into reciprocal use privileges and access agreements with other clubs and resorts, as the Club determines appropriate from time to time.
- Candidate acknowledges that the Membership Fee is non-refundable except as otherwise stated herein.
- Candidate acknowledges that a Single Preferred Membership is subject to renewal at the end of each year. The Club may decide whether to renew a Single Preferred Membership in its sole and absolute discretion and, if the Club offers an opportunity to renew a Single Preferred Membership, the terms and conditions for such renewal.
- Candidate acknowledges and agrees to be responsible for all charges incurred.
